Cllr Young: declared an interest in her role as Borough Councillor for Clandon & Horsley and as Sub on GBC Planning Committee

#### 23.004 Significant Correspondence

Cllr Young was approached by a local resident in the vicinity of Grove Fruit Farm, with concerns regarding the submitted application. Cllrs Young and Murray visited the resident on 16<sup>th</sup> January to discuss the matter and to view the site. The Planning Committee had already responded to this application with highway concerns and therefore Cllr Young, in her Guildford Borough capacity, agreed to follow up with the Planning Officer.

Update – The Planning Officer has confirmed that she will be reviewing this application within the next two weeks and that WHPC can still submit further concerns. Cllr Young made the Officer aware of the current enforcements that are open against this site and it was resolved at the meeting to submit a further objection to this application.
